he Society for the Advancement of Scandinavian Study wishes to express our outrage over the murders of George Floyd, Breonna Taylor, Ahmaud Arbery, and countless others, and to stand in solidarity with people of color who have been abused, oppressed, or murdered in the long and tragic history of white supremacy. Over the centuries, police brutality and racially motivated violence have played a key role in oppressing African Americans and other people of color in the United States. We condemn the systemic racism that pervades American culture and our criminal justice system and assert our strongly held conviction that Black lives matter.

As an academic organization, we acknowledge that the academy has often been complicit in white supremacy, and that it continues to be a place that is hostile to African Americans and other people of color. We commit ourselves to working to change that. We represent scholars dedicated to the study of the history and cultures of the Nordic region, an area of the world that is inextricably connected, both willingly and unwillingly, to the development of the inherent power structures that form the basis of inequity and injustice throughout the world. We acknowledge that it is our responsibility as scholars to pursue questions of race and inequality, seeking to expand the depth and breadth of our knowledge and to work to address these issues. We call on the members of SASS and colleagues across the Humanities to actively work to dismantle the systems of racism and oppression that not only pervade our country and the world, but also our universities, our research, and our classrooms. We can and must do better.

The President serves a two year term in which they function as the Chief Academic Officer of the Society. The President provides academic leadership to the society as well as providing oversight over the society's fundraising activities and acting as the liason between SASS leadership and the conference organizing committees. Immediately following their two year term, the President transitions into the role of Financial Officer.

Andrew Nestingen is professor of Scandinavian Studies and adjunct in Cinema and Media Studies at the University of Washington. He has served as department chair since 2015. He is author and editor of Transnational Cinema in a Global North (2005, co-edited with Trevor Elkington) Crime and Fantasy in Scandinavia (2008), Scandinavian Crime Fiction (2011, co-edited with Paula Arvas), The Films of Aki Kaurismäki (2013), and Nordic Noir, Adaptation, Appropriation (2020), co-edited with Linda Badley and Jaakko Seppälä. He served as review editor of Scandinavian Studies from 2014 to 2019.

Timothy R. Tangherlini has published widely on folklore, literature, film and critical geography. His main theoretical areas of interest are folk narrative, legend, popular culture, and critical geography. His main geographic areas of interest are the Nordic region (particularly Denmark and Iceland), the United States, and Korea. He is the author of Interpreting Legend: Danish Storytellers and their Repertoires (1994), Talking Trauma. Paramedics and Their Stories (1998), and the co-editor of Nationalism and the Construction of Korean Identity (1999), and Sitings. Critical Approaches to Korean Geography (2008). He has also produced or co-produced two documentary films, Talking Trauma: Storytelling Among Paramedics (1994) and Our Nation. A Korean Punk Rock Community (2002).

Kimberly earned her PhD from UCLA in 2016. Her research focuses on performance and adaptation in the Nordic region from the late medieval period until today. Her dissertation, *Uncovering Performance in Medieval Scandinavia*, explores the forgotten history of performance in the north prior to the Reformation. She has been a Teaching Fellow in Scandinavian at Augustana College since 2017 and has served as the Executive Director of SASS since February 2019.

The Executive Director is the only regular paid SASS employee. They function as the Chief Executive Officer of the Society, overseeing the day-to-day operations of the organization, including financial oversight, managing membership, and all internal and outward-facing communication. The Executive Director is responsible for ensuring that the Society follows all applicable government regulations for non-profit organizations, as well as the regulations and by-laws set out in the SASS Constitution.

Meet the Executive Council

The Executive Council is made up of eight members, representing the fields of Languages and Literature and History and Social Sciences. Members serve a four-year term, with two new members rotating in at the end of the annual conference. During their four years on the council, members fullfill the role of a board of directors. They serve on committees, propose new initiatives, and vote on proposals concerning the management of the society. The Executive Council meets virtually twice a year in January and September, and in person at the annual meeting in May.

Executive Council members representing History and Social Science serve on the Aurora Borealis committee in their first year, the Haugen and Conference Site selection committees in their second year, the Haugen and Audit committees in their third year, and the Conference Site selection committee in their fourth year. Additionally, members serve on various ad hoc committees at the request of the president.

Executive Council members representing Language and Literature serve on the Aurora Borealis and Conference Site selection committees in their first year, the Aurora Borealis committee in their second year, the Baldwin, Audit, and Conference Site selection committees in their third year, and the Baldwin committee in their fourth year. Additionally, members serve on various ad hoc committees at the request of the president.

Executive Council Members are elected by the full membership in a fall election. At the 2021 meeting in Seattle, we will be adding two additional seats to the council when we induct our first graduate student representatives. Details of the new graduate student positions will be announced in the October issue of News and Notes following the fall Executive Council Meeting.

Languages and Literature Fourh Year Member GANNT GURLEY University of Oregon Baldwin Committee

Gantt Gurley is Associate Professor of Scandinavian and the Director of The Harold Schnitzer Family Program in Judaic Studies at the University of Oregon. Before coming to University of Oregon he was a Harry Starr Fellow in Judaica at the Center for Jewish Studies at Harvard University. He received his Ph.D. in Danish literature from UC Berkeley in 2007. His first monograph Meir Aaron Goldschmidt and the Poetics of Jewish Fiction examines one of Denmark's greatest nationalistic writers as first and foremost a Jewish artist, exploring his relationship to the Hebrew Bible and later Rabbinical traditions such as the Talmud and the Midrash as a form of poetics. He is currently working on a book project concerning the legend of the Wandering Jew in European and American vernacular traditions.

Benjamin R. Teitelbaum is Assistant Professor of Ethnomusicology and International Affairs, and former Head of Nordic Studies, at the University of Colorado Boulder. His publications include articles in the journals Ethnomusicology, Scandinavian Studies, Arkiv/Scandinavian-Canadian Studies, Current Anthropology, Patterns of Prejudice, and American Music in addition to edited volume chapters. He is author of Lions of the North: Sounds of the New Nordic Radical Nationalism (Oxford 2017) and War for Eternity: The Return of Traditionalism and the Rise of the Populist Right (HarperCollins/Penguin 2020). In addition to scholarly venues, he has written for the New York Times, Foreign Policy, Dagbladet, the Los Angeles Review of Books, the Wall Street Journal, the Nation, and the Atlantic.




Call for Nominations Aurora Borealis 2020

Each year the Society honors graduate student contributions to our conference by awarding two student presenters the Aurora Borealis Prize for the best oral paper presentations, one in the category of History and Social Science, and one in Arts and Humanities. Typically only those who attend the delivery of a paper are eligible to nominate individuals for this prize, criteria we are not able to uphold due to the Coronavirus pandemic, which compelled the Society to cancel its 2020 annual meeting. Happily, the Aurora Borealis Prize Committee is still planning to award a 2020 prize and consequently, is adjusting the nomination process to accommodate the situation.

We invite faculty and instructors working with graduate students who have written worthy papers to nominate individuals for the 2020 prize. Self-nominated papers will be accepted on rare occasions at the discretion of the President of SASS.

As in recent years, the 2020 Aurora Borealis Prize Committee will operate a paperless submission process. Nominating faculty and instructors may submit their nominations via e-mail to the awards committee, auroraborealis@scandinavianstudy.org, and should inform the nominee of his/her/their nomination. Nominees may then submit their papers, along with any pertinent materials (audiovisual or other), to the same address via attachment. Please put Aurora Borealis in the subject line. Papers must adhere to professional citation standards and include a bibliography. Nominations and submissions will be accepted until December 1, 2020.

Suggestions Invited for New Editor of Scandinavian Studies

 ASS is seeking a new editor of its journal, Scandinavian Studies. The terms of the current editors, Susan Brantly and Thomas A. DuBois, were scheduled to end this year, though Susan and Tom have agreed to extend their work by another two years until 2022. The new editor's term, a five-year appointment, would therefore begin January 1, 2022 and run through December 31, 2026. Responsibilities include publishing four issues annually of Scandinavian Studies in coordination with the publisher, selecting content for issues, commissioning special issues, reviewing submissions, managing peer review, and managing manuscript preparation. SASS hopes to offer some support to the editor, as well as providing resources for networking on behalf of the journal.

The ideal candidate is a member of SASS with experience with Scandinavian Studies (as an author, a reviewer, and/or a member of the advisory council) or substantial editorial experience with another peer-reviewed scholarly journal. The new editor should also be conversant with developments in the field of Scandinavian Studies in its entirety (the study of the languages, cultures, or societies of the Nordic region, past or present). Scandinavian Studies is a membership journal striving to reflect the diversity of our members and their work through the publication of articles that represent the field in North America, Europe, and the world.
